

## Hillsboro Club Dock Policies

The Hillsboro Club will manage use of the dock facilities to benefit the greatest number of Members, as determined by Club management in its sole discretion.

1. Dockage shall be allocated on a first come, first served basis.
2. Dock hours are: Monday to Thursday from 9 a.m. to 6 p.m., Friday and Saturday from 9 a.m. to 10 p.m. and on Sunday from 9 a.m. to 7 p.m.
3. Members and non-members using The Hillsboro Club dock agree to be fully responsible for any damage to The Hillsboro Club dock and shall indemnify and hold harmless The Hillsboro Club for any such damage. Use of The Hillsboro Club dock can involve significant risk of personal injury or property damage, just as does the use of any dock in a high traffic area where there is a strong current. Therefore, use of The Hillsboro Club dock is at your own risk.
4. The Hillsboro Club shall not be responsible for any personal injury, damage to or theft of or from a Member's boat or for loss, damage or theft of any belongings, regardless of the cause while the dock is in use.
5. While using The Hillsboro Club dock, members and non-members and their guests shall abide by all rules of The Hillsboro Club and shall be subject to any and all directions and instructions by club personnel regarding such use.
6. No outside labor or independent contractors' work is allowed.
7. The boat owner acknowledges that the Club makes no representation regarding the adequacy of water levels for egress and ingress or other conditions such as current, traffic or boat wakes and the Club shall have no responsibility for such conditions.
8. Any breach of Club or dock policies, rules, and directives may be cause for the loss of dock privileges, removal of the vessel and revocation of Membership.
9. All boats docked at the Club must display a Hillsboro Club decal.
10. In addition to the policies contained herein, all persons using the dock facilities shall observe all other Club policies in effect for the use of Club facilities.
11. All vessels must have operable fire extinguishers and their own fenders as well as all other required safety equipment.
12. Rafting of vessels is not permitted.
13. No skateboarding, rollerblading or bicycling is permitted on the docks.
14. The walkway by the dock shall not be obstructed. Storage, supplies, materials, accessories or debris on the dock is not allowed.
15. The use of electric extensions is not allowed.

16. Boats belonging to Hillsboro Club Members may be towed from the dock without prior notice and at the owner's risk and expense if the boat: is docked in such a manner as to pose a danger to the dock or to other boats; is blocking entry to, or exit from, the dock by another authorized boat; poses a threat to health, safety or property because of fire, leaking fluids, taking on water, having sustained damage; not having been properly secured or maintained; or for any other reason which, in the opinion of management requires its removal from the dock.
17. Employees of the Club are prohibited from starting or operating boats, even at the owner's request.
18. Laundry shall not be hung on boats, decks, railings or the dock.
19. Items to be disposed must be put in trash containers provided in the dock area.
20. No open fire shall be permitted on boats, the dock, or on Club property.
21. No fish cleaning is allowed on the docks.
22. No food or beverage is allowed to be taken off a boat and brought onto the dock or Club property. Food and beverage service to the dock may be provided by the Club through the Catering department or Dining Room.
23. Children under the age of 14 are not permitted to be in the dock area unless accompanied by an adult.
24. Boat owners are responsible for the appropriate behavior and dress of guests and family members. Please respect the rights of others. Noise will be strictly regulated for the quiet enjoyment of all Members.
25. Pets are not permitted on the dock or in the dock area.
26. No fuel containers are allowed on the dock.
27. Swimming or diving is not permitted from boats or the dock.
28. Fishing is permitted from the dock.
29. No overnight dockage is allowed.
30. Any of the above mentioned rules may be changed or revised without prior notice.
